



**Anti-Corruption Declaration of Intent**  
**“MHC7 Together Against Corruption”**  
**Fiscal Year 2026**

I, Mrs. Siriporn Buddhipornopas, Director of Mental Health Center7, in the capacity of the Chief Executive Officer of Mental Health Center7, hereby declare and affirm my intention to lead the personnel of Mental Health Center7 in remaining steadfast in upholding the three institutional pillars of Thailand—namely, the Nation, Religion, and Monarchy—as well as the democratic system of government with His Majesty the King as Head of State. We shall carry out our official responsibilities in full compliance with Mental Health Center administrative values: honesty, unity, responsibility, accountability, transparency, achievement in work, courage to do what is right, adherence to the ethical standards of government officials, and strict observance of the Department of Mental Health’s Code of Conduct. We shall serve as role models, uphold the Department’s good image, and strengthen a sustainable culture of morality, free from corruption and misconduct, under the principle of “MHC7 Together Against Corruption.”

I hereby pledge to humbly follow in the royal footsteps by upholding and advancing the wisdom bestowed by our righteous King, conducting myself in accordance with the Sufficiency Economy Philosophy with utmost diligence, and standing firmly alongside honest individuals to preserve the enduring stability and prosperity of the Kingdom of Thailand.

## Declaration of Intent

### No Gift Policy

Fiscal Year 2026

---

I, Mrs. Siriporn Buddhipornopas, Director of Mental Health Center7, hereby declare a No-Gift Policy and affirm the commitment of all executives, officials, and personnel of Mental Health Center7 that Mental Health Center7 is an agency whose executives, officials, and personnel shall not accept any form of gifts or gratuities arising from the performance of their duties—whether before, during, or after carrying out their official responsibilities that may encourage corruption and misconduct both in the present and in the future. We will join forces in fostering an organizational culture grounded in honesty, integrity, and transparency, and in promoting positive attitudes and values in the performance of public duties with the ability to clearly distinguish between public and personal interests, consistently placing public interest above personal interest. We will cultivate public spirit, perform our duties with fairness and without discrimination, and refrain from any actions that may create a conflict of interest between public and personal interests. We also commit to not accepting any asset or benefit, whether directly or indirectly, that may be converted into financial value beyond what is legitimately permitted under the laws, rules, or regulations issued under legal authority; except for gifts or benefits expressly allowed for ethical reasons, in accordance with the criteria and quantity determined by the National Anti-Corruption Commission. We will strictly adhere to the ethical standards of government officials, the Department of Mental Health's Code of Conduct, and the Department's guidelines on the giving or receiving of gifts or benefits for officials at all positions and levels, including all relevant laws, regulations, and Cabinet resolutions to achieve the goals of "Zero Corruption and Wrongful Conducts MHC7" and "MHC7 Together Against Corruption."
